



St. Vrain Valley Schools Parking Permit Registration

To park in the student parking lot, students must have a valid parking permit.

Parent/Guardian or Student (18 and older) is responsible for maintaining vehicle registration, insurance and a valid driver's license. St. Vrain Valley Schools has the right to require proof of these at any time. Electronic submission of this form by the Parent/Guardian or Student (18 and older) is considered a Parent/Guardian or Student (18 and older) signature.

In order to obtain a parking permit each school year:

1. Parent/Guardian or Student (18 or older) must fill out the online registration for a parking permit.
2. Student driver pays the \$5 fee to the main office.
3. School staff will issue the parking permit once these steps are complete. PERMITS MUST BE DISPLAYED IN THE VEHICLE AT ALL TIMES.
4. Student drivers attending CDC or Innovation Center must display their school parking permit while parked at those locations.

Waiver/Indemnification

Disciplinary Action

Parking privileges may be revoked if the student driver does not abide by all St. Vrain Valley Schools Policies, school rules, and/or local law and traffic ordinances. In addition, detention, suspension, or towing (at vehicle owner's expense) may occur.

Per Board of Education policies JIH, JIH-R, and JIHB, if a situation arises, administration and/or local law enforcement have the right to search the vehicle.
